A RESOLUTION

Relating to the extension of the Fourth FSM Constitutional Convention.

3   section 6(1)(a) that the Fourth FSM Constitutional Convention may  
4   call recesses, if necessary; and

6   that a recess is necessary to enable Delegates to meet with their  
7   constituents to discuss the work of this Constitutional  
8   Convention; now, therefore,

11   recess from January 23, 2020, through February 23, 2020;
