

### A PROPOSAL

Relating to dual citizenship.

### BE IT RESOLVED BY THE CONSTITUTIONAL CONVENTION:

- 1 Article III of the Constitution of the Federated States of
- 2 Micronesia shall read as follows:
- 3 Section 1. A person who is a citizen of the Trust Territory
- 4 immediately prior to the effective date of this Constitution and a
- 5 domiciliary of a District ratifying this Constitution is a citizen
- 6 and national of the Federated States of Micronesia.
- 7 Section 2. A person born of parents one or both of whom are
- 8 citizens of the Federated States of Micronesia is a citizen and
- 9 national of the Federated States by birth.
- 10 Section 3. Citizenship of another country shall not affect a
- 11 person's Federated States of Micronesia citizenship, as provided
- 12 under Section 2.
- 13 Section 4. A person who has knowingly renounced his
- 14 citizenship of the Federated States of Micronesia shall remain a
- 15 national of the Federated States of Micronesia, except as may be
- 16 provided by law. A national of the Federated States of Micronesia
- 17 may regain his citizenship of the Federated States of Micronesia
- 18 in accordance with the residency requirement and other conditions
- 19 as may be prescribed by law.
